# New Features on the Company Watch System

July 2010

We are pleased to announce that a number of new features will be available on our Risk Management system from July 2010.

New Features

- **County Court Judgements (CCJs).** In addition to the CCJ summary already provided with the system, users will now be able to view individual CCJs including details of the court at which a judgement was given, along with the case number, date awarded and value.
- **Trading Addresses.** In addition to the Registered Office, trading addresses are now available. This enables users to identify where companies are operating, invaluable information when targeting potential clients.
- **Employee Titles / Key Contacts.** View a list of key contacts within a company (where available), including Marketing, Purchasing, & Sales Directors.
- **Brand & Trade Names.** View a list of the brand and trade names owned by a particular company. This information is displayed on the Document Filing screen.
- **Warning Notifications.** Greater prominence of the warning alerts (such as company in distress, late filing alert, unsatisfied CCJs, pending accounts etc) - these are now displayed at the top of the Health Profile screen.
- **Unconsolidated Parent Warning.** A warning notice will appear at the top of the Health Profile screen to alert you if the parent company is unconsolidated.
- **Enhancement to the calculation of the Credit Limit.** The Company Watch Credit Limit now takes into account the number and value of any CCJs recently served against the company.

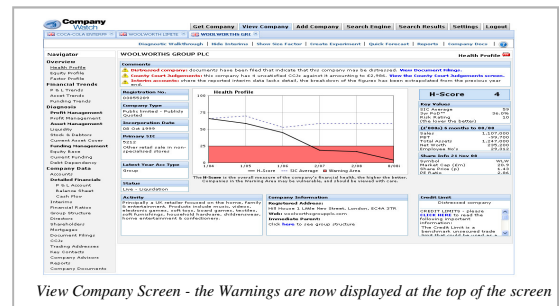
